Q1. Will the Honourable Minister please advise this Honourable House the basis on which billing is initiated by

Bermuda Hospital Board since the June 1st, 2019 fee for service was discontinued?

- A1. Since June 1st, 2019, billing is initiated by the Bermuda Hospitals Board when services are rendered to the following:
 - Persons not insured under a health insurance policy and do not qualify for subsidy.
 - Persons not insured under a health insurance policy and qualify for the aged subsidy which covers 70% and 80% for persons age 65 to 74 and age 75 and over respectively.
 - Services performed which are listed on the Bermuda Hospital Board's schedule 4B
 - Standard Health Benefits services provided prior to June 1, 2019
- Q2. Would the Honourable Minister please advise this Honourable House whether the service levels at the emergency department have been cut back, thereby creating unsatisfactory, inordinate delays for patient triage and attention, given that the hospital has been given a block grant which should allow adequate staffing?
- A2. No. The services at the emergency department at the Bermuda Hospital's Board have not been cut back.
- Q3. Will the Honourable Minister please advise this Honourable House how many referrals to outside (including overseas) services have been made by the Bermuda Hospital Board since June 1st, 2019 in light of the commitment of funding of a \$300M block grant to provide such services in house?
- A3. The Bermuda Hospitals Board does not regularly collect this data. This information is not available.
