Question Period.

MR. W.H. ROBAN provided written responses to parliamentary questions from MR. M.H. DUNKLEY as follows:-

Q1. Will the Honourable Minister please inform this Honourable House what is the mean time taken for the resolution of planning appeals for each year from January 1st, 2014 to December 31st, 2018?

A1. The typical length of time can vary anywhere between three to six months.

There are a multitude of variables that impact the length of time it takes to process an appeal, including:

- whether the appeal is lodged by the applicant or a third party;
- whether there were objections filed for the original planning application;
- the time taken by the appellant to respond to the Director's Case produced by the Department of Planning; and
- the availability of the overseas planning inspector to provide an independent assessment.
- **Q2.** Would the Honourable Minister please inform this Honourable House how many planning applications per month have been handled for each

planning officer in the Department of Planning from January 1st, 2014 to March 31st, 2019?

A2. Currently statistics collected are not collated by planner. However the chart below identifies number of completed planning applications for the time period from January 1st, 2014 to March 31st, 2019.

- a total of 8 Enforcement Notices have been issued;
- 41 Direct Action cases have occurred which are those instances where an Enforcement letter or interview with the landowner causes them to remove the unauthorized work; and
- The following table confirms the number of complaints regarding unauthorized development that were received by the Department of Planning.
