Will the Honourable Minister please provide this Honourable House with the procurement methodology document(s) and detail the rigorous technical and procurement evaluation utilized by the Bermuda Housing Corporation (“BHC”)/Bermuda Land Management Company (“BLMC”)/AHAC for the purposes of evaluating proposals made for the projects listed in the Minister’s statement to this Honorable House on 26th June 2026?

2. Will the Honourable Minister please provide this Honourable House with a full listing of all proposals received and considered by the AHAC for the developments at Morgan’s Point, Victoria Place and Albert Row and Tommy Fox Road to which the Minister referred in his statement of 26th June 2026 to this Honourable House? Including (i) the name of the entities that made proposals, (ii) date(s) the proposal(s) was/were considered by the AHAC, (iii) the overall number of units that the entity was proposing to build, (iv) the cost per square foot of each unit in the proposal(s), and (v) the reason(s) each proposal was either recommended for acceptance or rejection by the AHAC?
3. A statement released to the media dated 21 July 2026, by the Ministry of Housing and Municipalities said, “Following the technical assessment, Committee representatives visited the manufacturing facilities of some vendors to conduct direct evaluations of completed housing installations utilizing the proposed systems, including an on-site inspection of capsule housing units in use to assess performance under actual occupancy and environmental conditions. This formed part of the Committee’s broader due diligence process prior to making its recommendations.” Will the Honourable Minister please advise this Honourable House of (i) the names of each manufacturer visited by AHAC representatives and/or the Minister, (ii) the date of the visits to the manufacturer by AHAC representatives and/or the Minister, (iii) the identity of the representatives of the manufacturer that the AHAC representatives and/or the Minister met, and (iv) the costs of all travel expenses incurred by BHC/AHAC/BLMC/the Ministry of Housing and Municipalities to attend the meetings with the said manufacturers?
